Honoring Jon Cooper

Honoring JON COOPER

Jon Cooper is a well-known Long Island businessman and past Suffolk County legislator. He's poised to broaden the base of public support for Huntington Hospital, a "world-class medical facility that's right here in our hometown," he said. "Huntington Hospital is probably our single most important institution. In many ways, it's the very heart of our community."

"I've lived in this community for more than three decades," he said. "My husband Robert and I raised our five children here. I'm thrilled to support the vital work the hospital does to deliver top quality health care to residents."

Mr. Cooper is president of Spectronics Corporation, a leading manufacturer of ultraviolet equipment and fluorescent materials in Westbury that was founded in 1955 and now has 160 employees. Last year he also formed Alerton International, a start-up company that develops

products to improve safety among mine workers.

Mr. Cooper set a record as the longest-serving legislative majority leader in the history of Suffolk County. "It was the best 12 years of my life," he said.

While serving in the local legislature, Mr. Cooper introduced a number of landmark bills. He may be best known for authoring the first law banning use of cell phones while driving. In 2000, Suffolk County became the nation's first to adopt such a ban.

Mr. Cooper and his family live in the village of Lloyd Harbor in Huntington Township. "This is our hospital. It's here to serve all of us in our times of need," he said. "But in return, I feel that we as a community need to step forward and help provide ongoing financial support for the critical health care services and programs that Huntington provides."
